## Consider a Life Membership

ICTA offers a life membership option. The \$500 payment can be made via a single payment or five \$100 payments. Once the \$500 membership fee is fully paid, the member no longer pays a membership fee and if they choose to attend the convention, do so at a reduced convention rate.

If you wish to begin a payment option for the 2015 year and attend the 2015 convention, you would pay \$260. That amount gets you current membership (\$60), convention attendance (\$100), and your first payment (\$100) accomplished. Once all five payments are completed, then you would only need to pay the \$100 convention fee or whatever convention fee is imposed at that time. Members who are considering long term commitment to the Association will find this option to be money saving.

### **2015 ICTA Award Winners**

The Awards Committee has been hard at work this summer sifting through the various nominations for the Annual Illinois Communication and Theatre Association's prestigious awards. After careful consideration, the committee made the recommendations below, which have been accepted by the Executive Board.

The winner of the **W.P. Sandford Presidential Award**, which recognizes long term contributions to ICTA & to the profession, is **Judy Santacaterina** from Northern Illinois University. The Sandford Presidential Award recognizes long, exceptional and distinguished service to the Illinois Communication and Theatre Association over an extended period of at least 15 years.

**Doug Jennings**, who recently retired from Illinois State University, has been selected as the recipient as the **Edith Harrod Award**, which recognizes outstanding contributions in the field of speech communication and/or theatre by an Illinois speech educator. The qualifications include outstanding achievement in the profession as well as distinguished service to ICTA.

The newest of the ICTA awards is the **Connie Link Outstanding Mentor Award**. The qualifications for this award include distinguished service to the association and outstanding achievement in the profession, especially in mentorship or teachers and/or speech/theatre coaches and directors. This year ICTA honors two recipients of this award: **Marvin Kleinau & Marion Kleinau**, who both taught at Southern Illinois University.

The **Jerry Mathis Outstanding Young Teacher Award** recognizes an outstanding young communication and/or theatre educator in Illinois. This year's recipient is **Anna Wright**, who teaches at Illinois State University.

The **L. E. Norton Award Outstanding Higher Education Student Award** recognizes an outstanding higher education student enrolled in any Illinois college or university who is majoring in speech communication and/or theatre. The recipient must have demonstrated outstanding leadership and significant service within his/her department in particular, and to the college or university and community in general. The **undergraduate recipient** of this award is **Marques Brown**, who is currently a communications major at Eastern Illinois University. The graduate recipient of the award is **Yanelly Villegas**, who currently attends Northern Illinois University.

The **Richard A. Hunsaker Outstanding Secondary School Speech Student Award** recognizes an outstanding secondary education student enrolled in any Illinois high school. This year's recipient is **Callen Brown**, who just graduated from United Township High School. She received her award earlier this spring.

These awards will be presented at the ICTA convention in September. ICTA congratulates the accomplishments and service of these outstanding award winners.

## Illinois Well Represented at NSDA Nationals

The State of Illinois was well represented at the 2015 National Speech and Debate Association's National Tournament in Dallas, Texas. 23 schools from the 3 Illinois districts attended the tournament. Several Students advanced to the Top 60 and Top 30 in Main Events. The following students advanced to Semi-Final Rounds of Main Events: Dramatic Interpretation: Georgette Voss (Buffalo Grove High School) and Presleigh Renner (Hinsdale Central High School), Original Oratory: Jimmy McDermott (Prospect High School), and Julia Couillard (Downers Grove South High School). In Policy Debate, Brian Roche (Glenbrook North High School) took sixth place as a speaker while Anthony Trufanov and Ryan Spector (Glenbook North High School) placed fourth and first respectively. The team of Trufanov and Spector were also crowned National Champions in Policy Debate.

Following the success in Main Events, Illinois was very well represented in Supplemental events as well. Erik Thomas (Southland College Prep Charter High School) was named the National Champion in Poetry Reading while teammate Charnnia Jones took third place in Prose Reading. In Extemporaneous Commentary, Parth Patel (Huntley High School) took fifth place and Bethany Dain from Belleville West High School took second. Illinois had half of the finalists in Expository Speaking including Donnie Bland (Belleville West High School) who took fifth place, Parth Patel (Huntley High School) who took fourth, and Viraat Goel (University High School) who took third. ### **By-Law Update Proposal**

At the 2014 Annual Business Meeting, a proposal to include language about the John M Hires Distinguished Service Award (which has been awarded for several years to those that have made distinguished service to the field of High School Individual Events) in the ICTA By-Laws was tabled and later sent to the Long Range Planning Committee for review. Throughout the year, the Committee, in consultation with the Executive Board, agreed to formalize that award and allow the opportunity for the leadership in the other areas of competitive high school and collegiate competitive speech, debate, and theater to create similar awards. Thus, the Executive Board will be proposing the following language added to the By-Laws:

5.6 ICTA Sponsored Awards. These awards are to recognize extended distinguished service in the area of speech, debate, and drama. The awards are sponsored and funded by ICTA, and they will be selected and presented by the governing bodies and/or state chairs of the specific activities in consultation with the Executive Vice President of ICTA. Cost for these awards will be determined on a yearly basis as a part of the annual awards budget, and the Executive Vice President will facilitate payment for these awards.

### The Gift of Discernment

I want to begin by thanking everyone who has helped me ensure that the Newsletter is getting off to a wonderful reboot! Please feel free to submit any accomplishment, news item, or other piece of information that you think will be useful to be shared with the entirety of the membership of ICTA. After watching the most recent Republican Debate (or what the main stream media is being told was a debate), I think one idea has been made crystal clear to me: WE NEED ORAL COMMUNICATION NOW MORE THAN EVER BEFORE. For those of you that are unaware, I left my teaching position at United Township High School in May for an English Faculty Associate position at University High School. I am fortunate enough to be returning to a school where I will be teaching two classes in Debate and Rhetoric and two classes of Sophomore Oral Communication. As we enter a Presidential Election Cycle, it will be important for us to teach our students to make an informed decision. Advocacy of a specific candidate is NEVER the goal. I think it is also worth mentioning that students have every right to be frustrated with the idea of voting or becoming politically engaged in our current political climate. Many times we all are as well, but for different reasons. We may be frustrated that education policy does not always reflect best practices, or that we are paying too much or too little in taxes. The frustration of our students comes out of the fact that they have not found their passion, or they do not understand that becoming politically engaged will actually help them work with their passion. As educators of communication skills, we must aid our students in making this crucial connection. The best gift we can give to our students is not always the content of our courses, but the skills in critical analysis. In a world of a 24 hour news cycle and seven major corporations controlling almost all of our media outlets, now, more than ever before do young people need to have the gift of discernment. It is our job to help students realize, they have had the gift all along.
